1. Purpose. To publish the Academy's Institutional Review Board membership.

2. Action

a. Pursuant to the requirements of references (a), (b) and (c), the United States Naval Academy (USNA) has established an IRB, which shall be referred to as the "Academy's IRB". The Academy's IRB is an administrative body, composed of scientists, engineers, and nonscientists, appointed to safeguard the welfare and rights of and the data about human subjects recruited to participate in research projects conducted under the authority of the USNA. In this capacity, the Academy's IRB will review all proposed research that is to be conducted under the jurisdiction of USNA and that directly or indirectly involves human subjects and/or the data about them.

b. The following appointments are effective immediately. Terms of appointment will be determined on an individual basis, subject to the availability of the member.
